## **ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, the Government of Kerala has constituted a permanant State Health Agency to carry out all activities with regard to implementation of KASP in the State. The tender for the Year 2020-21 has been published on the 20<sup>th</sup> of February 2020. As per the letter read as 2<sup>nd</sup> paper above, the Special Officer, KASP has requested to constitute a High Level committee to evaluate tenders under Insurance Mode for Karunya Arogya Suraksha Padhathi for the Year 2020-21 and Government after examining the matter constituted a High Level Committee with following members for the above purpose vide G.O read as third paper above.

Later, vide Government Order read as fourth paper it was ordered to implement the KASP scheme in an assurance mode where the claims of private Hospitals alone will be serviced by a Third party administrator/Implementation support agency. Hence the already floated insurance tender was cancelled and a fresh tender was floated on the 3<sup>rd</sup> of May 2020 and the tender opening and Evaluation scheduled on 20<sup>th</sup> May, 2020. The Special Officer, KASP vide Letter read as 5<sup>th</sup> paper above has requested the Government to amend the former order to incorporate the necessary changes for evaluation of the tender under assurance mode.

3. Government after having examined the matter in detail and are pleased to form the Evaluation Committee mentioned as  $3^{rd}$  paper above for evaluation of the tender floated on the  $3^{rd}$  of May, 2020 under Assurance Mode.
