Alternatively, the amount can be directly credited online and the screenshot of the online payment to be attached in the application while applying for

the post. All communication including the interview call letter from the State Health Agency (SHA) side will only through email. The applicants should have a valid email id.

5. The selected candidate should be willing to relocate or to travel anywhere in the state and should be willing to work in any district of Kerala as decided by SHA.
6. The applicants should be excellent in writing skills both in English and Malayalam and should be proficient in computer. Thorough knowledge of MS office is essential.
