- the post. All communication including the interview call letter from the State Health Agency (SHA) side will only through email. The applicants should have a valid email id.

- 5. The selected candidate should be willing to relocate or to travel anywhere in the state and should be willing to work in any district of Kerala as decided by SHA.
- 6. The applicants should be excellent in writing skills both in English and Malayalam and should be proficient in computer. Thorough knowledge of MS office is essential.
- 7. The post is for immediate requirement. The selection will be based on Qualification, Experience, and performance in the interview. Ineligible applicants shall be avoided at any stage of the recruitment.
