1. For the above positions, the mode of appointment is contract basis for Regional Medical Auditor, Executive -IT, Executive -Hospital Networking, Field Officer.

- 2. The age limit for applying for all the above positions is 40 years as on 01.07.2023.
- 3. The application should be submitted in the prescribed format attached with this notification. The applications forwarded other than the prescribed application form. in www.sha.kerala.gov.in will NOT BE CONSIDERED.
- 4. The applications that are <u>not complete in all respect will not be considered</u> for shortlisting and no further communication will be done in this regard.
- 5. The applicants for deputation should be from Kerala State Health Service Department. The emoluments paid in the parent department shall be the emoluments for the post. Candidates working under Kerala State Government should attach duly filled Form No. 144 of KSR. Such applicants are expected to apply through the proper channel. They shall compulsorily produce 'No Objection Certificate' from the employer at the time of interview. The submission of NOC is a mandatory condition for appearing in the interview. It will be the responsibility of the individual to submit NOC before the interview.
- 6. Application fee is Rs. 600/- (Rupees SixHundred only). The amount should be deposited in bank account no:195305000419 with ICICI Bank, Vazhuthacaud (IFSC Code: ICIC0001953) in thename of "KARUNYA AROGYA SURAKSHA PADATHI OPERATIONS". The Receipt / Counter foil should be attached in the application. Alternatively, the amount can be directly credited online and the screenshot of the online payment to be attached in the application while applying for the post. No other mode of payment of fee will be accepted.
- 7. All communication including the interview call letter from the State Health Agency (SHA) side will only be through email. The applicants should have a valid email id. The candidates with the prescribed qualification & experience only need to apply for the above positions. Ineligible applications will be rejected, and no further communication will be done in this regard. The fee once paid will not be refunded under any circumstances.
- 8. Candidates are advised to browse the website: "www.sha.kerala.gov.in" regularly for updates / notices and announcements.
- 9. The selected candidate should be willing to relocate or to travel anywhere in the state and should be willing to work in any district of Kerala as decided by SHA.
- 10. The applicants should be excellent in writing skills both in English and Malayalam and should be proficient in computer. Thorough knowledge of MS office is essential.
- 11. Recruitment is for immediate requirement. The selection will be based on Qualification, Experience, and performance in the written test / interview or both, however applicable. Experience acquired till the date of this notification only be considered. Ineligible applicants shall be avoided at any stage of the recruitment.

- 12. The successful candidate needs to enter into a contract agreement with the State Health Agency (SHA). The successful candidates will be appointed on a contract basis with consolidated pay initially for a period of three months from the date of joining. Based on the performance and integrity of the candidate, the contract appointment may extend further as per the requirement of the State Health Agency.
- 13. Claims in respect of qualifications or experience etc. should be supported by self-attested copies of relevant documents in the application; fail to do so will lead to rejection of the application. Offer letter, appointment order, salary slip etc. will not be considered as proof of experience. Candidates are required to produce the originals at the time of interview or when demanded by SHA.
- 14. It will be ideal to provide references, especially the names of superior officers whom the candidate had worked with in the previous organization.
- 15. Candidates are also advised to avoid contacting the head of the office over the phone to clear doubts / seeking information, as far as possible. SHA will provide necessary communications on the official website. In addition, the candidates will get the details of the queries raised over the email.
- 16. No TA/DA will be paid for the written test / interview.
- 17. The posts are temporary in nature during the period of the operation of the State Health Agency (SHA) and no claim for permanency of job or labour claims to the Government.
- 18. Canvassing in any form will lead to automatic disqualification. Candidates are advised to desist from such unholy practices.
