The Chair informed everyone that the SHA will verify each TPA's documents based on the checklist, and if any shortfalls will be identified, the same will be communicated to the TPA to provide additional documents or clarification, if found necessary. The technical evaluation will be finalized and approved only after the High Level Technical Committee of SHA has reviewed it, and the SHA will then consider which TPAs are eligible to participate in the Financial Bid.

The SHA analyzed the documents uploaded by each TPA based on the technical evaluation check list, which includes tender clause reference numbers such as 7.7.1a, 7.7.1b, 7.7.1c, 7.7.1d, 7.7.1e(ii), 7.7.1e(iii), 7.7.1e(iii), 7.7.1e(iv), and 7.7.1e(iv).

Some of the shortfalls have been identified based on the verification of TPA documents, which incudes -

 Vidal Health Insurance TPA Pvt Ltd - Audited Balance Sheet + P & L statement with Auditors report of financial year 2021-2022 (Due to the illegibility of the uploaded documents) Minutes_Selection of New TPA_Private_Technical Bid Evaluation by Internal Committee_18.10.2023

- Paramount Health Services & Insurance TPA Pvt Ltd State Specific Experience Certificates (particularly the number of claims in Category A and B states)
- FHPL Health Insurance TPA Pvt Ltd Qual 5-3 Required for the previous fiscal year, IRDAI Extract (illegible).

The Joint Director Operations stated that any shortfalls discovered should be mailed to SHA by 04:00 PM on October 19, 2023.

The Chair informed all TPAs that the High Level Committee would conduct additional scrutiny for further evaluation. Following the evaluation, the technically qualified TPAs would be qualified for Financial Bid.
