AB PMJAY Quality Certification



What?

AB-PMJAY Quality Certification programme is a joint initiative by National Health Authority (NHA) and Quality Council of India (QCI) with a vision to strengthen the healthcare ecosystem and benchmark the ~20000 empanelled hospitals on the quality parameters.

The certification programme is a three-tier system as below:

- 1. Gold Quality Certification
- 2. Silver Quality Certification
- 3. Bronze Quality Certification



Why?

- 'Quality healthcare' is one of the mottos of the scheme. Continuous efforts are being made by the authorities to set clearer guidelines that require stringent enforcement to create a robust regulatory framework for the scheme. It, therefore, becomes critical to define a quality framework based on the basic principles of patient safety that enables to monitor and measure adverse events and take corrective and preventive measures as and when required.
- Strengthening the healthcare ecosystem in India by motivating hospitals in increasing their quality of service over time



How?

- Digital Process which includes two type of assessment
 - 1. Desktop Assessment
 - 2. Onsite Assessment
- For silver and Gold only desktop assessment








Journey of Excellence – Quality Certifications

The certification programme is a three-tier system as depicted below:










Quality Healthcare with AB PMJAY

- Empaneled hospital data shows that Most of the hospitals empaneled across India under AB PMJAY have less than 50 beds
- Bronze quality certification has been designed in such a way that it act as a single guideline for such small size hospitals and aspire them to achieve quality healthcare protocols while keeping prime focus on 'patient safety' so that trust amongst the beneficiaries can be maintained regarding scheme and hospital's services

Bronze Quality Standards

(at a Glance)

Key Inputs

This criteria broadly covers structural part of the hospital.

Clinical Services

This determines outcome of services and quality of care.

Support Services

This criteria covers fundamental aspects from areas like legal and statutory compliance, bio medical waste etc.

Patient Care

This includes standards such as patient confidentiality, consent and patient rights.

Health Outcome

It includes measuring and reporting the patient experience, mortality rate, infection rate, bed occupancy rate etc.

Steps/Stage	Average time taken by hospital*
Application Stage	30 Days
Desktop Assessment	7 Days
Desktop Assessment NCs	15-20 Days
Onsite Assessment	7 days
Onsite Assessment NCs	15-20 Days
Final Result/certification	3 Days

^{*} It is just the average time, some hospitals where able to get the certification in less than 30 days

Eligibility for AB PMJAY Quality certification

Empanelled Hospitals

A Hospital Empanelled under AB PMJAY scheme with NHA does not require to qualify any other parameters in to apply for Bronze Quality Certification

Non-Certified Hospitals

Non-Empanelled Hospitals

A Non-Empanelled Hospitals will be eligible for the Bronze Quality Certification if:

- They have at least 25 operational beds
 (except for Dental and Eye Care centres)
- They have no prior certification from any national or international hospital accreditation organization
- They provide services as per the health benefit packages offered under AB PMJAY

- GOLD
 NABH's Full Accreditation/



Bronze Quality Certification Process

(for Empanelled hospital)


- The Empanelled hospitals which are not certified by any accreditation body will have to apply for bronze certificate in order to get the quality certification
- 100% compliance on the bronze quality standards will be required to get the certification



Bronze Quality Certification Process

(for Non-Empaneled hospital)

 Process is similar to that of empaneled hospital only difference is that non-empaneled hospital has to visit certification site first and get themselves registered there.



Certification for already certified hospitals

(Silver and Gold)

- NABH's Entry-Level can apply directly for AB PMJAY Silver quality certification
- NABH's Full Accreditation/ JCI/ACHS accreditation/NQAS National Level Certification with all the 18 departments certified hospital can apply for AB PMJAY Gold quality certification directly
