### ORDER

The Government of India has recently announced the NHPS (National Health Protection Scheme) benefit package under Ayushman Bharat - Pradhana Mantri Jan Arogya Yojana (AB-PMJAY) in the place of the present RSBY Scheme which aims to provide secondary and tertiary coverage upto Rupees 5 Lakh. As per the Government Order read above, Government have decided to implement Ayushman Bharat-Pradhana Mantri Jan Arogya Yojana (AB- PMJAY) in the State with effect from 01.04.2019 as Karunya Arogya Suraksha Padhathi (KASP). Constitution of a State Health Agency is essential for the smooth functioning of the Scheme. Hence Comprehensive Health Insurance Agency Kerala (CHIAK) has been designated as State Health Agency for the implementation of KASP in the State as per Government Order read second above till alternative arrangement is made.

In order to ensure that KASP insurance scheme is managed properly with dedicated structures, the detail proposal of constituting State Health Agency has been submitted. The CHIAK was handling RSBY and CHIS Plus and other insurance schemes before introduction of KASP. CHIAK will handle the legacy issues related to these schemes.

The Government have examined the matter in detail and are pleased to constitute a permanent State Health Agency (SHA) to carry out all activities with regard to the implementation of KASP in the state. Sanction is also accorded for the creation of the following 33 posts for the smooth functioning of the State Health Agency (SHA).
