1. For the above position(s), the mode of appointment is on contract basis only. The age limit for applying for all the above position(s) is 40 years as on 01.08.2025.
2. The application should be submitted in the prescribed format attached with this notification. The applications forwarded other than in the prescribed application form in www.sha.kerala.gov.in will NOT BE CONSIDERED.
3. Candidates who are willing to apply for more than one position, should submit separate applications with fee paid separately for each position (as applicable).
4. Application fee is Rs.600/- (Rupees Six Hundred Only). The amount should be deposited in Bank Account No: 39153436238 with State Bank of India, Althara Branch (IFSC Code: SBIN0007203) in the name of "STATE HEALTH AGENCY KERALA". The Receipt / Counter foil should be attached in the application. Alternatively, the amount can be directly credited online and the screenshot of the online payment to be attached in the application while applying for the post. No other mode of payment of fee will be accepted. No application fee for the post of Regional Medical Auditor and Executive (IT).
5. All communication including the interview call letter from the State Health Agency (SHA) side will only be through email. The applicants should have a valid email id.
6. The candidates with the prescribed qualification & experience ONLY need to apply for the above positions. Ineligible applications (by any means) will be rejected, and no further communication will be made in this regard. The fee once paid will not be refunded under any circumstances.
7. Claims in respect of qualifications or experience etc. should be supported by self-attested copies of relevant documents in the application. Failing to do so will lead to rejection of the application. Offer letter, appointment order, salary slip etc. will not be considered as proof of experience. Candidates are required to produce the originals at the time of interview or when demanded by SHA.
8. The applications that are NOT complete in all respect will not be considered for shortlisting and NO further communication will be done in this regard.
9. The applicants should be excellent in writing skills both in English and Malayalam and should be proficient in computer. Thorough knowledge of MS office is essential.
10. It will be ideal to provide references, especially the names of superior officers whom the candidate had worked with in the previous organization.
11. Candidates are advised to browse the website: "www.sha.kerala.gov.in" regularly for updates / notices and announcements.
12. Recruitment is for immediate requirement. The selection will be based on Qualification, Experience, and performance in the written test / interview or both or any other

selection method adopted by SHA, however applicable. Experience acquired till the date of this notification only be considered. If found ineligible, such applicants will be avoided at any stage of the recruitment.

13. The TOR for the above position(s) is annexed with this notification / published in the website of SHA. The TOR may get changed or modified from time to time based on the need of SHA.
14. The selected candidate(s) should be willing to travel anywhere in the state or country and should be willing to work in any district of Kerala as decided by SHA.
15. The successful candidate needs to enter into a contract agreement with the State Health Agency (SHA). The successful candidates will be appointed on contract basis with consolidated pay, initially for a period of three months from the date of joining or up to 31st of March of the current financial year, whichever the earliest. Based on the performance, integrity of the candidate, the need of SHA, the contract appointment may extend further as per the requirement of the State Health Agency.
16. The post(s) are temporary in nature during the period of the operation of the State Health Agency (SHA) and there is no claim for permanency of job or labour claims to the Government.
17. The State Health Agency reserves the sole discretion to decide whether or not to fill the vacancies. The number of vacancies is subject to increase or decrease. The validity of the final rank list will be for a period of one year from the date of publication, and any vacancies arising during this period may be filled from the same list.
18. All selected candidates will be governed by rules and regulations of the State Health Agency (SHA) from time to time.
